#### Good morning-

Nancy and I have reviewed this document. There are some standards and indicators that we have not met, and may not be able to before July 26th.

- 1. We need to fill the public sector vacancy on the board- since our meeting is not until Aug 3rd, I am not sure we can meet this.
- 2. We need to fill both PC positions on the board. Since PC has not met in quite some time due to the lack of participation, HS has started to recruit for new members. PC elections happen in August, so we will not be able to meet this standard.
- 3. There are some Board members still missing, or out of date with conflict of interest statements. They are looking for conflict of interest policies from resigned board members- including PC appointees.

We need to re-send to all members, and have them return it to us no later than July 15, however, will not be able to get the conflict of interest for resigned board members.

- 4. Salary comp. study of the CEO was not included in the supporting documents- we can send the study done by Delark and meet this standard.
- 5. We need to set up a sweep account that can handle the limits of all of our accounts in order to meet the requirement that our total balance be 100% insured by FDIC at all times.
- 6. We need to add language to the Fiscal Policy that speaks to procurement of leases and purchase alternatives.
- 7. We need to provide C&FS committee meeting minutes that speak to and address the discussion of performance of CSBG workplan.

During ELT meeting tomorrow- we will come up with a plan to get these items completed and submitted in time.

After this, I see us still scoring below perfect as it is impossible to seat three board members by July 26, and to get the singed CoI from board members who have resigned.
