#### **Updates from Office of Head Start:**

- Head Start / Early Head Start Non-Competing Continuation Grant for Budget Period 4/1/22 3/31/23: The NOA (Notice of Award) was received on 2/17/22.
- Focus Area 2 Review: No information on the review as of yet.

#### **Program Updates**

- **Hiring:** Interviews are ongoing for all open positions.
  - New Assistant Director of Education and Center-based Services Hired! Amber Mahoney started on February 22. Amber will be supervising all of the Center Coordinators and ensuring that all centers are licensed through NYS Office of Children and Family Services (OCFS). Amber will also supervise the Education Coordinator, Disabilities Manager and Practice-based Coach; she will be ensuring that curriculum activities are implemented to fidelity for all of Center-based and Home-based services.
- Vacancies: Head Start Program has 23 Vacancies as of this report.

#### COVID:

- All staff eligible to be boosted are now boosted.
- Staff, children and visitors to the centers are still required to wear a mask under the Interim Final Rule which is still in the comment period. OCFS has removed the mask requirement.

#### • In Person Comprehensive Services:

 Effective February 28 all services are provided in person. We will continue to offer virtual access to families who still are unable to attend in person meetings. All Home Visits will take place in person.
